i. Allotments

Dave Bird reported that a half plot was now vacant – there was no one on the waiting list but someone moving into the village shortly was interested in taking this on – agreed that they could have it. The gatepost at the allotment entrance would need replacing soon.

Dave Robbins had nothing to report. Janet Jackson had now stepped down as West Bexington Homewatch Coordinator – there would be an item in the Bride Valley News asking for a replacement.

v. Transport

Anna Lovell advised that the 31 Bus would run later in the evening & on Sundays from May 2015. The X53 Bus would run hourly from 3rd May 2015. The safety concerns re the Thorners School Bus which were raised at the December 2014 meeting was still an issue- in the mornings this bus bypassed Puncknowle going to West Bexington first & collecting children from Puncknowle (& Swyre) on the

way back – but children have to go across the road from the Bus Shelter to board the bus which was parked on private property. – agreed to write to Dorset County Council School Transport & send a copy of letter to Thorners School & WATAG.
