1. APOLOGIES FOR ABSENCE

2. DECLARATIONS OF INTEREST

3. PUBLIC TIME

County Councillor Coatsworth advised that Dorset County Council was working towards a Combined Council in 2 ½ years' time which would be responsible for wider issues. Health – the CCG now controls Drs Surgeries and there will be consultation re hospitals and other services shortly.

6. CHAIRPERSON'S REPORT

7. REPRESENTATIVES REPORT

i. Allotments

Dave Bird reported that the Allotment Committee Inspection had been held. There were 2 new Allotment holders and everyone was working hard.

ii. Footpaths

Dave Bird reported that the Dorset County Council Rights of Way Team had cleared the Footpath at Knackers Hole and were working in the local area. The willow tree overhanging the wall at Greystones, Puncknowle – the Chairman would report.

iii. Homewatch And Community Police Report

PCSO Dave Ash reported that in the last few days car tyres had been slashed on 2 vehicles in Swyre.

iv. Playing Field Committee

Councillor Heaver reported that the painting of the woodwork in the Playing Field had been completed last Tuesday. The owner of the adjoining hedge at No 9 Looke Lane wanted to replace this with a fence - need to check who owns this. Ken Bodycombe from Magna Housing was retiring.

v. Transport

Councillor Taylor reported that there were plans to try to amalgamate school buses with Public Transport to make more use of buses coming back empty. The 210 Bus is on the list of buses under review.

vi. Village Hall

Councillor Sinclair advised that the outside facia of the Hall would be replaced and a carbon monoxide detector fitted. Jill Neill was now in charge of the 100 Club and Liz Slater was again taking the Bookings. There would now be a £5 per hour Hall charge to play table tennis.

vii. Bridport Local Area Partnership

Councillor Fry had attended the BLAP AGM where the 2 speakers were George Streatfeild from Melplash Show Society who were trying to educate youngsters on Farming and a speaker from the Pilsdon Community who provide 20 dorms for people needing help to get back on their feet. Maureen Jackson continues as Chair of the BLAP Steering Group. Superfast Broadband had been discussed - the rest of Puncknowle & Swyre would be connected by early 2017. Only 24% of people who could access the faster internet speeds have signed up with their provider.

viii. DAPTC

There had been no meetings.

ix. Puncknowle, Swyre & West Bexington Web Site

The Website was still not being updated at present which means that the Parish Council is not complying with the Transparency Code.

- 4. <u>Tree Application No WD/TP/16/00177</u> Tamarisk Farm, West Bexington (Renewal of TP/12/00438) 1 Macrocarpa Remove 3 lower limbs & crown No objections

Decisions:

A. Tree Application No WD/CA/16/00132 – Golly Knapp View, Hoopers Lane, Puncknowle – 1 Conifer - Fell & 1 Beech – Fell – Consent Granted – Agreed to write to Jean Marshall, Head of WDDC Planning raising concerns that these trees should have been worth saving.

Other Planning Issues:

a) Issues at Small Holding at Hazel Lane, Puncknowle – the occupant had been tipping building waste on this site for some years – he agreed to continue tidying up this site and this situation would be reviewed in 12 months' time before the Environment Services get involved. The fence that had been erected along the verge below this plot would be reviewed by Dorset County Council's Solicitor.

11. PROPOSED NEW DEFIBRILLATOR AT WEST BEXINGTON

It was agreed to order the defibrillator at a cost of £1800 plus vat from South Western Ambulance Service. This defibrillator would be fitted to a wall at the Manor Hotel, West Bexington. There would be an anonymous donation of £1000 towards this and it was agreed that the remaining funds from the "Chalet Fund" should be requested from WDDC. There was also the £300 received last year from Kudos Studios (the filming of Broadchurch) which would be used towards this purchase.

12. FILMING OF BROADCHURCH (3rd Series) at BEACH ROAD, WEST BEXINGTON

Kudos Studios would be filming part of the 3rd Series of Broadchurch at Beach Road, West Bexington during July, September and October 2016. Beach Road would be closed for short periods at a time for the filming at Farthing Cottage starting on Monday 4th July 2016.
