3. PUBLIC TIME

Anna Lovell advised that the Annual Beach Clean would be on Sunday 26th April 2015 10am to 12am at West Bexington Beach.

County Councillor Ron Coatsworth reported that the New Waste Site at Broomhill would be operating from July 2015 with the Recycling Centre starting in September 2015.

The Coastal Path at West Bexington – Ian Jackson confirmed details of the proposed clearance of the coastal path west of the West Bexington Car Park. The digger hire from Fowlers would cost £79 per day plus fuel & delivery/collections fees. The digger driver was charging £100 per day making a total cost of approx £575. Councillors agreed to this work being done & it was agreed to approach West Dorset District Council for funds from the "Chalet Fund".

Councillors agreed to ask the WDDC Planning Officers to extend the Permitted Development Rights on the Chalets at West Bexington to include the grass area adjacent to the Chalets (which had been refused permission).

ii. Councillors Heaver & Fry had rodded the drain outside of the Old Rectory, Puncknowle but this 15 inch pipe was still blocked farther down. Water had been diverted from the garden of the Old Rectory and onto the road which was causing erosion of the verges and the surface of the road. Dorset County Council Highways to be asked to look into this issue.
