6. CHAIRPERSON'S REPORT

Councillor Buckland advised that the Dorset Best Kept Village Competition Presentation would be held at Morden Village Hall on Thursday 18th September 2014 from 7pm & asked for a Councillor to attend. There was now £924.84 still available from the West Dorset Fund after the 2 stone benches had been paid for. There would be a short meeting of the Napper Charity Trustees following on from this one, to discuss an application for funds.

7. REPRESENTATIVES REPORTS

i. Allotments

Councillor Heaver reported that the Allotment gate had been fixed by Dave Robbins. There was now a bonfire rota with 6 volunteers. The weed problem of "Mare's Tail" at the top of the Allotments was being dealt with. The 2 vacant allotments had been taken and there were no vacancies at present. The Allotment AGM would be on Friday 3rd October at 7.30pm in the Village Hall.

ii. Footpaths

Dave Bird reported that there had been lots of cutting back of vegetation from the local footpaths & it was good to see that other villagers were helping with this. The Coastal footpath at West Bexington – there was a petition on the bar of the Manor Hotel, West Bexington.

iii. Homewatch

Nothing to report.

iv. Playing Field Committee

Councillor Heaver reported that the Playing Field Committee meeting had been held on 8th July 2014 in the Playing Field – 11 items were noted for attention & 7 had been done already. There were splits of 6mm in the new equipment & if these increase to 8mm Sovereign will come & sort it out. Asbestos had fallen off

the gutters of the garages into the Playing Field- he would talk to the garage owners about removal to Weymouth Recycling Centre.

v. Transport

Anna Lovell advised that the New Bus Time Tables from 28th September 2014 were out. The 47 Bus to Yeovil was on the Agenda for discussion at the Cabinet meeting tomorrow. No buses would be going via Shipton Gorge – road works starting Monday 8th September 2014.

vi. Village Hall

Councillor Sinclair reported that work to the yard starts in September.

Councillor Simon reported that BLAP had had their usual stand at Melplash Show in August. The Coastal Communities Group was meeting next week & Councillor Simon to attend.
