3. PUBLIC TIME

County Councillor Ron Coatsworth advised that there would be a Public Meeting on 13th October 2013 re the Adoption of the Local Plan. Section 106 was being replaced. The Local Authorities of Bournemouth, Poole, Christchurch & East Dorset want to combine with the rest of Dorset.

The Main meeting continued:

4. MINUTES OF PREVIOUS MEETING

Resolved that the minutes of the Council's meeting held on 1st September 2015 be agreed and signed as a correct record.

5. MATTERS ARISING FROM THE PREVIOUS MEETING

Item 12 – Information Items d) Safety concerns following the accident at West Bexington Beach – A reply had been received from HM Coroner's office & Councillor Sinclair was collecting information to send on.

Item 9 Highways c) – The uneven surface at Swyre past the Church had been reported many times but it shows on the dorsetforyou website as being completed.

Item 9 Highways d) - The hedge on the bend going into Swyre from Puncknowle had now been cut back.

6. CHAIRPERSON'S REPORT

Councillor Fry advised that he & Councillor Buckland had attended the Best Kept Village Presentation at Puddletown. Mentioned were the War Memorial at Swyre- so thanks go to Ian Jackson, Barry Pye & Derek Heaver for their work on this and also the Playhouse in Puncknowle Playing Field.

7. REPRESENTATIVES REPORT

i. Allotments

Councillor Heaver reported that the Allotment AGM had been held on Friday 25th September 2015 but not many Allotment Holders had attended. It was suggested that this AGM not be held on a Friday night in future. The "marestail" had again been treated at the top end of the Orchard. There had been a bumper apple & plum harvest this year.

ii. Footpaths

No Report but Footpath 3 at Swyre would be discussed later under Item 9) Highways.

iii. Homewatch

PCSO Dave Ash had sent his apologies & emailed his report – the only issue raised had been a complaint from a local resident of cars parking for the Village Hall outside of her house – this was not a Police issue.

iv. Playing Field Committee

Councillor Heaver reported that he & Dave Robbins had erected the new guard posts around the swings. The woodwork would be treated with jeyes fluid before the winter & the wall on the left side of the big gate will be repaired.

v. Transport

Anna Lovell advised that there would be an emergency meeting re access of the 44 Bus at the Crown Roundabout at Bridport.

vi. Village Hall

Councillor Sinclair reported that the Village Hall AGM had been held last night, Mike Brown had stood down from the committee & they need a Social Secretary, although Paul Pritchard was moving house and leaving the parish he would, nonetheless, continue as Chairman. The Accounts had not yet been audited. Maintenance – most jobs had been done & new Emergency Lights were in place. A Table Tennis table for the hall had been suggested.

vii. Bridport Local Area Partnership

Councillor Fry gave an update on the BLAP meeting he had attended. Concerns were raised on transport to Hospital – patients can only claim 12pence per mile for hospital cars but it may actually cost up to 50pence per mile. Care workers were now paid inclusive of travelling time leaving less time caring for patients. Grass cutting in Bridport – a Grant had been made by Dorset County Council to Bridport Town Council. The West Dorset Partnership Review was not fit for purpose. The Neighbourhood Plan for the Bridport area was going forward. Affordable Housing – it was difficult to purchase land at reasonable prices.

viii. DAPTC

The DAPTC AGM would be held on Saturday 7th November 2015 at 10am at Dorchester. The 5 motions at this AGM had been circulated by email.

ix. Puncknowle, Swyre & West Bexington Web Site

Agreed to send a letter of thanks to Mike Brown for all the work he had done on the Villages Website in the last few years. Diane Sinclair may be willing to take on the updating of this Website in the short term.

Councillor Heaver advised that salt supplies were adequate at present and further supplies could be purchased later if needed. There were the 9 people in Puncknowle ready to spread salt as required. To ask DCC Highways again if the gritting lorry could reverse into the West Bexington road to grit an extra 5 yards down the hill.
