2. DECLARATIONS OF INTEREST

3. PUBLIC TIME

Dave Bird advised that the Minutes of the June Meeting should read that Councillor Heaver gave the Allotment Report & not him. He also advised that not all Allotments were being kept tidy & there should be an Allotment Inspection soon.

6. MATTERS ARISING FROM THE PREVIOUS MEETINGS

Meeting 7th June 2016:- Item 7. Representatives Report - i.) Allotments - Dave Bird had advised (in Public Time) that Councillor Heaver had given the Allotment Report (not him) – these Minutes were amended.

7. CHAIRPERSON'S REPORT

Councillor Fry reported that Kudos Studios were filming the 3rd Series of Broadchurch at Farthing Cottage, Beach Road, West Bexington for the next few weeks and again in September and October. There would be a donation made to the Parish Council to be spent on a project at West Bexington. The figure of £500 had been suggested & it was agreed to discuss this project further when the money had been received.

iii. Homewatch And Community Police Report

Councillor Robbins reported that a chain had been cut on a locked gate near the Timberyard, Puncknowle. The Homewatch sign at Swyre needed replacing.

iv. Playing Field Committee

Councillor Heaver reported that the Playing Field Inspection Report had been circulated and 2 small items needed to be done. The ownership of the boundary hedge with No 9 Looke Lane is still to be confirmed.

It was agreed to write to the Village Hall Committee to clarify the criteria for the Parish Council Grant which is £500 this year. This is for the maintenance of the Village Hall and would be paid subject to receipt of a copy invoice for the work done and a copy of the Village Hall maintenance schedule.
