1. APOLOGIES FOR ABSENCE

2. DECLARATIONS OF INTEREST

3. PUBLIC TIME

Anna Lovell asked why the surface of the road at Swyre (from the Church to the B3157) had not been repaired – this problem had already been reported to DCC Highways. The Coast Watch had confirmed that there were no funds available for installing a phone on West Bexington Beach. County Councillor Ron Coatsworth advised that the Health Service would be reorganised over the next 5 years with the location of Hospitals a big issue. The NHS consultation form was available on the internet. The next DCC Scrutiny meeting would be held on 21st December 2016.

8. REPRESENTATIVES REPORT

i. Allotments

Derek Heaver reported that the Allotment hedge along the east side had been cleared by Nigel Arak-Newman & his son.

iii. Homewatch And Community Police Report

PCSO Luke White & PCSO Pete Smith were now working in the Beaminster Area –they had replaced PCSO Dave Ash – their e-mail details to be forwarded to the Homewatch coordinators. There had been some vandalism of property at West Bexington.

iv. Playing Field Committee

Councillor Heaver reported that jobs for the winter period would be clearing weeds and treating the woodwork with Jeyes Fluid.

v. Transport

Anna Lovell reported that First Buses had been "On Strike" but this had now been resolved. The 210 Bus may be under review next July. There was talk of withdrawing the 73 Bus which takes 12 children from Bridport to Powerstock School. It was suggested that the Chairmen of the local Parish Councils in the Bride Valley should meet to discuss the future of the Community Bus.

vi. Village Hall

An email had been received from Jill Neill re work that would be eligible for the £500 Grant for the Village Hall - The dishwasher would be serviced & repaired rather than replaced.

vii. Bridport Local Area Partnership

The Chairman had attended the BLAP Steering Group meeting last week where Bus Passes had been discussed & it was agreed that these passes should be used by elderly people in the middle of the day instead of the over 60's using it to go to work. The Coast Watch have the building at Hive Beach, Burton Bradstock for a further 3 years.

viii. DAPTC

The Chairman had also attended the DAPTC AGM on Saturday 5th November 2016.

ix. Puncknowle, Swyre & West Bexington Web Site

The website was just "ticking over" but needed more input.

- a) Reduction in Highways funding and local choices (See Item 14. Other Finance £2500 set in the 2017/2018 Budget to cover the additional costs). Dorset County Council would only be cutting the verges once a year. There will be courses on Pot Holes & how to manage traffic when working on the Highway.
- b) Overgrown hedges at Golly Knapp Farm, Puncknowle DCC Highways had written to the 2 owners of these hedges but nothing had yet been done Agreed to contact Blair Turner again.
- c) The road had been marked at Swyre Cross, Swyre and the gully to be cleared.
