1. APOLOGIES FOR ABSENCE

3. PUBLIC TIME

Anna Lovell advised that there would be a Meeting re the CCG Consultation on Wednesday 8th February in Bridport Town Hall at 7.30 pm. There would be a "Future of Transport" meeting on Friday 24th February 11 am in Bridport WI Hall. The Dorset Beach Clean would be on either Sunday 23rd or Monday 24th April 2017.

Dog Fouling was still a problem at West Bexington. Further to the Meeting held at West Bexington in October 2016 re Broadband and telephones – Agreed to write to BT again for progress. There were Pot Holes along Swyre Road, West Bexington - Clerk to send details to everyone again on how to report these issues "online".

Councillor Ron Coatsworth advised on the Health Service reorganisation over the next 5 years with the proposed Hospital closures – that nothing in this area will be affected.

4. MINUTES OF PREVIOUS MEETING

Resolved that the minutes of the Council's meeting held on 6th December 2016 be agreed and signed as a correct record.

5. MATTERS ARISING FROM THE PREVIOUS MEETING

Item 12. Consultation re disconnection of BT Phone Boxes – It was Agreed that all 3 Telephone Boxes should be Adopted by the Parish Council- Clerk to find out further details for this.

6. CHAIRPERSON'S REPORT

The Chairman had attended all the local (Bride Valley) Parish Council meetings where the Bus Services had been discussed (See Item 7. v. Transport). The South Western Ambulance Service would be at the Manor Hotel at West Bexington to demonstrate the New Defibrillator on Saturday 11^{th} February 2017-2 pm to 4 pm. The Avian (Bird) Flu was in the area at Abbotsbury Swannery and there were local "back-yard" hens that were not complying with DEFRA Rules.

Dave Bird had reported that the Allotments were very wet.

iv. Playing Field Committee

Councillor Heaver reported that the woodwork had been sprayed with Jeyes Fluid and the swing safety matting cleared. The Annual Inspection was due in May. A letter had been received asking for permission to use the Playing Field for access to the back garden of No 2 Looke Lane,

Puncknowle, to carry out extensive work to the back garden – concerns were raised re possible damage to the grass and tarmac surfaces and Health & Safety issues – it was agreed that this permission should not be granted.

v. Transport

The Chairman reported that after July 2017 the 210 Bus would not be put out to tender. A local taxi driver was willing to provide transport for 2 days per week (at reasonable rates) for up to 4 people per trip. Ron Coatsworth would be attending the Dorset County Council meeting where Transport would be on the Agenda. Anna Lovell reported that passengers using the Ring & Ride can use their Bus passes. There were Funds available for The Community Bus Scheme but only as a one off,

vi. Village Hall

There had been an inspection in the kitchen and it was recommended that an extractor fan be installed. The cooker was to be replaced, an invoice from Peach Electrical for £999.00 was presented and it was agreed that the £500 Grant available to the Village Hall should be paid towards this expense.

- 1. <u>Tree Application No WD/CA/17/00004</u> 15 Napier Close, Puncknowle Fell 5 Trees Councillors had Agreed to Object to this Application & the Comments Form had already been sent to the Planning Office, but the Application had now been Withdrawn.
- 2. <u>Tree Application No WD/CA/17/000011</u> Delve Cottage, Church Street, Puncknowle Fell 1 Elder Tree No Objections
- 3. <u>WD/D/16/002702</u> School House, Swyre Conversion of existing garage into Holiday Let No Objections providing a Section 106 Agreement is attached to any Approval linking this Garage to the School House.
- 4. Application No WD/D/16/002181 Bride Valley Nurseries, Looke Mead, Litton Cheney (Adjoining Parish Consultation) There are numerous parts to this Application. Issues were found with several and it was Agreed that the Application as a whole should be objected to. The house was only Granted Permission (on Appeal) on Condition that the structures including the barn, lean-to, poly tunnel pod 2, car port, etc. were removed there are no other Wind Turbines in The Valley & this would set a "Precedent" for future Wind Turbine Development. 3 Wind Turbines seems excessive for the size of the business. Concerns were also raised at the number of wild birds killed by hitting Wind Turbine blades. This site is in a Flood Zone and has been flooded numerous times in the last 10 years Agreed to Object.
