3. PUBLIC TIME

- a) Councillor Marsh reminded the meeting about the broken Public Notice Board at West Bexington the suggestion was that the 2 Notice Boards at Swyre be moved to West Bexington and a new larger Notice Board be purchased for Swyre which would be one half for Parish Council & the other side for Public Notices Agreed to put on the Agenda for discussion at the October 2018 meeting.
- b) Councillor Marsh raised the problem of the road opposite the new build (Meadfoot) at Swyre Road, West Bexington which had been damaged by builders vans & delivery Lorries to the site an email had been sent to the Agent some months ago but no reply had been received.
- c) Councillor Marsh advised that the Rowan tree on the grass outside of his property at West Bexington was dying and asked if a tree application was needed to have it cut down.
- d) Anna Lovell asked about the repairs on the culvert at Swyre as the road would be closed while this was done Agreed to ask Highways for a schedule for these works.

i. Allotments

Debbie Legge thanked Dave Bird for all his work on the Allotment Committee over many years. Ernest Watson had purchased a 2^{nd} hand sit-on mower which was for the use of all the Allotment Holders to cut the orchard grass. There were still $2\frac{1}{2}$ Allotment Plots vacant. SSE had contacted Councillor Heaver and would be cutting back the trees near their wires. Concerns had been raised about the tap that had been put on the 2^{nd} water trough – agreed to monitor the water usage and this would be raised at the Allotment AGM to be held on Thursday 27^{th} September 2017 at 7.30 pm.

ii. Footpaths

Dave Bird reported that he had taken the hedge cutter up to Knackers Hole and had also cut back vegetation at Bull Lane, Swyre.

iii. Homewatch And Community Police Report

The report from PCSO Alex Bishop was read: On Wednesday 8th August, unknown offenders had stolen electrical equipment from a garage that was left insecure, in West Bexington. He advise that any buildings,

especially those containing items of value are locked when left unattended and an alarm installed. For any security advice, please contact him.

iv. Playing Field Committee

Councillor Heaver reported that he had met with Ken Hussy in the Playing Field who had recommended that the easterly pole of the Drop Rope Traverse be put into a new position to make more room for the new sunken trampoline – this pole would be completed next week. The extra safety matting would bring the total figure for the trampoline to approx. £5310.00 plus the cost of the commemorative plaque. No digger would be needed - Nigel Arak-Newman & he would dig by hand. It was hoped to have this trampoline in position before 11th November 2018 to hold an Event.
