He thanked Nigel Arak Newman for all his work in helping him to prepare the site and install the trampoline.

11. ALL ASPECTS OF THE ALLOTMENT FIELD

The Chairman reported that the Allotment Holders only pay rent for their Allotments and not the Orchard and the Willows at the top of the Allotment Field. This needed to be formalised with a Management Plan and Agreements drawn up to include a "pepper-corn" rent (that may or may not be collected). The Allotment Committee would meet to discuss further & report back to the December 2018 Meeting. The issue of the future use of Water/bills to also be discussed. The boundary hedges were getting out of hand and it needs to be investigated as to the ownership of each hedge/ditch as the fields either side of the Allotments were in the process of being sold.
