1. APOLOGIES FOR ABSENCE

2. DECLARATIONS OF INTEREST

Both Councillors J. Arak-Newman & D. Heaver Declared an Interest in Item 10) All Aspects of the Allotment Field (As an Allotment Plot Holder)

3. PUBLIC TIME

Anna Lovell reported that there was a large pot hole at Swyre, near the telephone box.

4. MINUTES OF PREVIOUS MEETING

Resolved that the Minutes of the Council's meeting held on 6th November 2018 be agreed and signed as a correct record.

5. MATTERS ARISING FROM THE PREVIOUS MEETING

6. CHAIRPERSON'S REPORT

Councillor Fry advised that when the previous Clerk had registered the Napper Charity details of the Allotment Field with the Land Registry in 2004, the 9 Councillors serving on the Parish Council at that time were named as Trustees. Most of those listed were no longer Parish Councillors but were still on the Land Registry Records. A local Solicitor had agreed to sort this issue out and would waive her fee. There may be a fee of about £40 to pay to the Land Registry Office.

7. REPRESENTATIVES REPORT

i. Allotments

ii. Footpaths

Dave Bird advised that Footpath 1 to Litton Cheney which had been reported by a resident of Litton Cheney as blocked with a growing crop had now been cleared.

iii. Homewatch And Community Police Report

There were several computer scams going around, but no other crimes to report.

iv. Playing Field Committee

Councillor Heaver advised that the Opening Ceremony for the Sunken Trampoline on Sunday 11th November had been very well attended and involved many children from the villages. The disabled ramp had now been delivered but Ken Hussey had advised not to put this in as it will block part of the trampoline. The leaf clearing would take place on Saturday 15th December 2019 at 11 am (weather permitting).

v. Transport

Councillor Taylor gave a report on the last WATAG meeting – Dorset has the worst set of transport cuts in the South West. From October to Easter there is no Bus Service on a Sunday to Bridport. The 40 Bus Route had been cancelled without consultation. Dorset County Council had promised to keep provisions of Buses to the end of March 2019 but this is not happening. There is now no Bus Service between Bridport

& Yeovil. The link between Stations (Weymouth, Dorchester, and Yeovil) would be funded by SW Rail (Trains).

vi. Village Hall

The Hall Committee were holding a Christmas Tea on Sunday 9^{th} December 2018 - 2.30 pm to 4.30 pm followed by a candle lit walk to the Church for the Carol Service at 5 pm. The Chairman had requested that the Grant of £500 for 2018/2019 be paid now towards the cost of the installation of the New Boiler.

8. PLANNING

Applications on which the Parish Council were consulted: -

1. <u>Application No WD/D/18/002662</u> –Manor Farm, Swyre – Erection of steel framed Livestock Building – as this application had only been received today and was not yet on the dorsetforyou website – the Parish Councillors were unable to discuss or decide tonight.

9. HIGHWAYS ISSUES

- a) Road Closure The B3157 would be closed at Swyre (going west towards Bridport) from 18th January 2019 to 28th January 2019 daily from 9.00 am to 4.00 pm. (The Road would open in evenings & weekends).
- Dorset County Council were carrying out gully work in the area over the next couple of weeks.

10. ALL ASPECTS OF THE ALLOTMENT FIELD

The Chairman reported that a formalised Management Plan and Agreement needed to be drawn up with the Allotment Holders and the Napper Charity Trust/ The Parish Council. It was agreed that the Allotment Holders would pay a "pepper-corn" rent for the Orchard (if called for). Future Water bills to be paid by the Allotment Holders and bills should be sent to Councillor Heaver as Allotment Secretary. The ownership of the boundary hedges were still being investigated and once this was established it was agreed that Peter Yeates of Swyre (as a National Hedge-layer & Judge) be asked for advice about the future management of these hedges.

No details or quotes had been received for new Notice Boards – Agreed to discuss at the February meeting.

Councillor Marsh again raised the problem of the road opposite the new build (Meadfoot) at Swyre Road, West Bexington which had been damaged by builders vans & delivery Lorries to the site emails had been sent to the Agent some months ago but still no reply had been received Highways to be contacted now.
