2. DECLARATIONS OF INTEREST

3. PUBLIC TIME

Mark Roberts provided a brief update as Ward Councillor and hopes to provide more information in December about the new Dorset Council Plan.

4. MINUTES OF PREVIOUS MEETING

5. MATTERS ARISING FROM THE PREVIOUS MEETING

A workshop was held in Bridport on 22 October by Dorset Council to consult with town and parish councils about how their relationship with Dorset Council will be constructed going forwards. No one was able to attend from the parish, but a report of the outcome will be made available to the parish council.
