Flooding right across the bottom of Rectory Lane has become a recurrent problem. This has been reported to Highways but it was agreed that further discussion was warranted in the hope that some improvement can be found to the current drainage system, since it is not coping in heavy rain. It was noted that when flooding occurs, it is not visible to drivers at night.

6. CHAIRPERSON'S REPORT

The provision of a defibrillator in Swyre and West Bexington is being looked into. In Swyre, some CIL money is available, plus local residents will be holding a fund-raising event in the new year. A replacement defibrillator will be required at West Bexington as soon as the current provider gives notice to remove it; the lead time for ordering a new machine is believed to be one week or less. CIL money will partly fund the replacement in West Bexington and other funds are being sought. Research is being undertaken into the best option for sourcing both of these.

The Chairman has undertaken to restore various finger posts in the parish. This will require the purchase of 25 finger post letters costing probably under £50. All in favour to support this purchase.
