6. UPDATE REGARDING CAR PARK AND PARKING AND OTHER ISSUES AT WEST BEXINGTON.

The council has been in contact with car parking services about amending the car park regulations. It is felt that street parking must be addressed before any changes are made to the car park. Councillor Marsh spoke to a senior manager in Dorset Council Highways Department about traffic regulation in West Bexington on 2 October and is awaiting a further meeting to examine all of the options before the survey can be sent out to the residents.

7. CHAIRPERSON'S REPORT

1. Co-option of new members

The current advertisement for councillor vacancies ends on 31 October. Applications for co-option will be considered at the next meeting.

2. Provision of Defibrillators

The chairman has made and erected the new sign next to the phone box in Puncknowle directing people to the village hall and defibrillator. It is anticipated that the new defibrillator for Swyre will be installed shortly.

8. CLERK'S REPORT

- 1 Update on the request for a Memorial in Swyre.
 - It was agreed that this is not a project for the parish council. A working party is currently being assembled which will include residents and bereaved relatives. The clerk will be consulted if it is felt that the parish council can help once a desired outcome has been agreed upon.
- The contract for cutting the grass in Puncknowle Playing Field expires on 31 March 2021. It was **Resolved** to make a minor amendment to decrease the height of the cut: Proposed PG Fry, seconded Buckland, AIF. Tenders will be invited via the Bride Valley News in November and December, and on the noticeboards and website.
- 3 Resuming Physical Meetings
 - Although the Village Hall is now able to re-open, it is not felt that parish council meetings are able to be held in person under the present conditions.
